Terms of the "OTE Satellite Internet" Programs

The prices include 23% VAT and regard 24-month length connections.

Static IP can be added or removed at any time, in any Program. There is no minimum duration commitment.

The special equipment, with lump-sum 350€ of the total cost, is provided free of charge for a limited amount of time.

The lump-sum activation fee of 99€ is addressed exclusively to the new subscribers of the service, given that they procure the equipment from OTE.

In case there is a disruption before the 24 months have passed, a lump-sum disengagement fee of 250€ is charged.

If the "OTE Satellite Internet" Program is converted into a Program of a lower monthly fee (within or after the commitment period), a lump-sum relegation fee of 25€ is charged at each time.
